Ein neues Großhandels-Vertriebszentrum wird eingerichtet, das als Drehscheibe für die Auftragsabwicklung und die Lieferung auf der letzten Meile dient.

Schließlich werden Investitionen in den Aufbau eines Online-Vertriebskanals und die entsprechende Integration der Lieferkette angestrebt. Dies wird es ermöglichen, dass unser Portfolio an Geflügel-, Eier- und Fleischprodukten direkt über E-Commerce-Marktplätze und Plattformen, die von großen Supermärkten und Hypermärkten genutzt werden, gelistet und gekauft werden kann.

Insgesamt zielt diese Expansion darauf ab, das Unternehmen als einen führenden voll integrierten Anbieter in der Region zu positionieren
