## Operative Goldmine in Erkundung

Kirgisistan hat viele der größten Goldminen in Zentralasien.

An den nördlichen Hängen der Kirgisischen Gebirgskette, im Oberlauf, den rechten Komponenten des Karabulak-Stroms, im zentralen Teil der Bulakashinsky-Erzfelder gelegen.

Vulkanisches Gestein ist Teil der geologischen Struktur des Ortes. Gesteine, die durch Andesite und Andesitbasalte, ihre Tuffe und Klastolaven repräsentiert werden. Intrusivgestein wird durch Gabbro-Sonkinite, Syenit-Diorite und Granodiorite repräsentiert, die separate Phasen eines einzigen Intrusivkomplexes sind. Ein charakteristisches Merkmal der Formationen dieses Komplexes ist ihr blattförmiges, sanft abfallendes Vorkommen mit Neigungswinkeln von 10 o bis zu 50 o in den umliegenden vulkanisch-sedimentären Gesteinen.

Mit diesen Strukturen und in Verbindung mit der Bildung von mineralisierten Zonen und Erzkörpern der Lagerstätte.

Die identifizierten Gold- und Kupfermineralisierungen sowie die Zonen der Beresitisierung und Verkieselung am Standort Severny sind entweder direkt auf Granodiorit-Intrusionen oder, was häufiger vorkommt, auf ihre intrusiven Kontakte mit dem vulkanogenen und intrusiven Muttergestein beschränkt.

Die Zonenbreite der Beresitisierung erreicht hier die ersten zehn Meter. verfolgte Länge auf 400 m. Unter den Beresiten ist die intensivste Aderung Verkieselung, mit verstreuten Sulfiden von Kupfer, Blei, Eisen und Molybdän.

### Keypoints

Die Goldlagerstätte ist eigentlich ein großes Feld, das aus mehreren Goldlagerstätten und 1 Kupferlagerstätte besteht. Der Verkäufer behauptet, einen hohen Goldgehalt zu haben (prozentualer Goldgehalt pro 1 Tonne). Das Feld ist jedoch nicht gut entwickelt. Alle Daten werden von sowjetischen Ingenieuren gesammelt und es scheint, dass sich seit dieser Zeit nichts getan hat.

Die Reserven, die nach kanadischen oder australischen Standards als P1 und P2 eingestuft werden, sind gleichzusetzen mit: Explorationsergebnisse, Explorationsziele, Explorationspotenzial oder sogar einige als Inferred. Dies ist die niedrigste Stufe der Erkundung
