Seit langem beschäftigt sich das Unternehmen mit der Konstruktion und Herstellung von Formen für viele wertvolle Unternehmen des Landes. 1990 Gestaltung des ersten Werkzeugkastens mit der eingetragenen Marke. Das Unternehmen hat zu dieser Zeit begonnen, Hersteller von Kunststoff-Lagergeräten zu werden. Das Design und die Marke waren damals eine Premiere für den heimischen Markt.

Mit diesem Start, der eine sehr positive Reaktion ausgelöst hat, hat das Unternehmen die Produktpalette schnell erweitert und 1993 mit dem Export begonnen.

2004 übersiedelte das Unternehmen in das derzeitige Werk und strebt nach wie vor nach weltweiter Produkt- und Servicequalität.

Das Unternehmen hat die Vision, mit den notwendigen Quellen für bessere Qualität und besseren Service ausgestattet zu sein.

Seit Mai 2002 ist das System von der AQA American Quality Accessories unter ISO9001:2000 zertifiziert.

Die Fabrik befindet sich auf einer Gesamtfläche von 10.000 m², von denen 8.000 m² die geschlossene Produktionsfläche sind, die mit vollautomatischen, hochwertigen Kunststoffspritz- und Verarbeitungsmaschinen ausgestattet ist.
