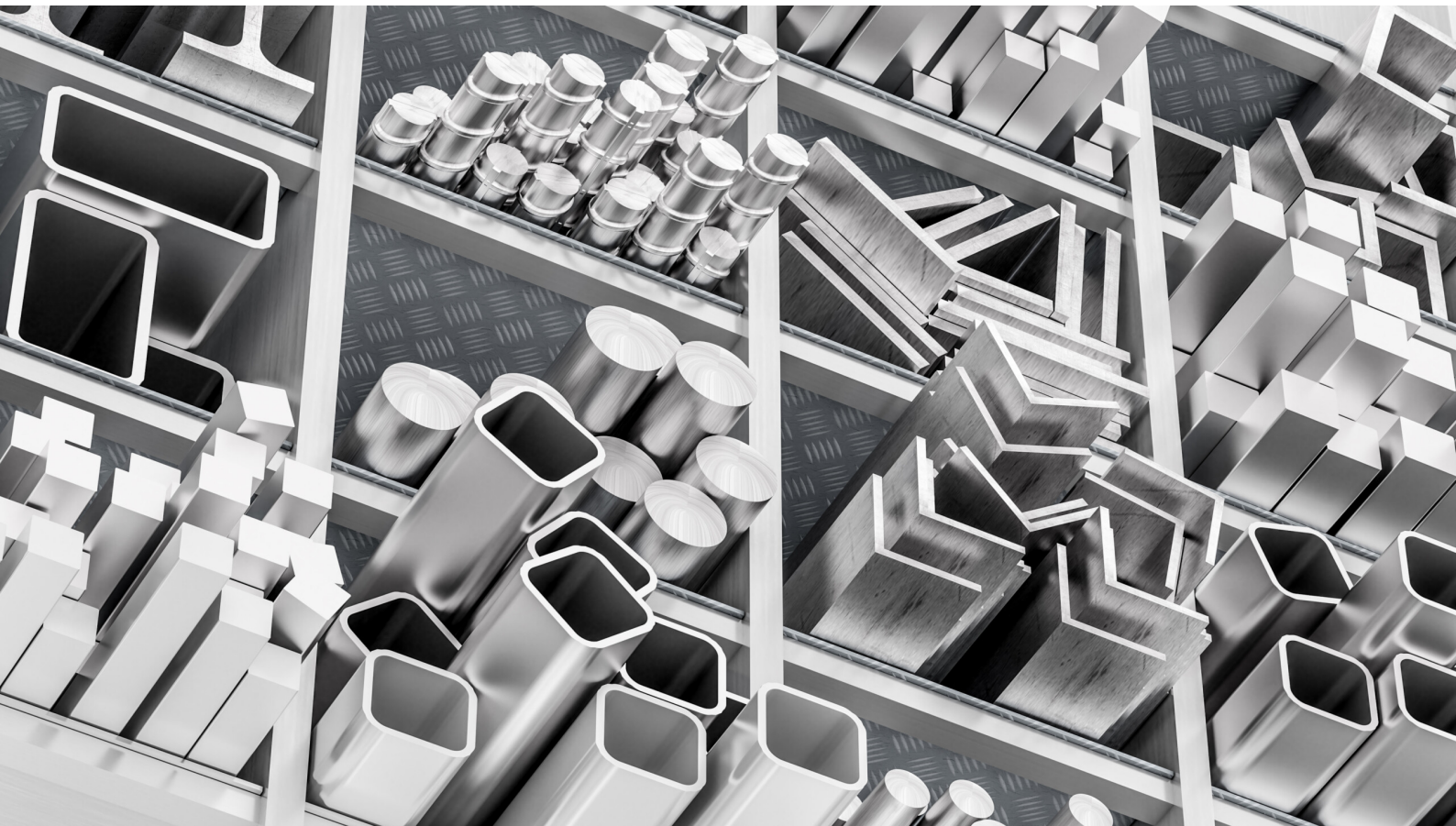

## Hersteller von Aluminiumprofilen

Das 1991 gegründete Unternehmen ist einer der führenden Hersteller von Aluminiumprofilen in der Türkei und steht zum Verkauf. Die Metal Company ist in der Nähe von Istanbul auf einer Gesamtfläche von mehr als 40.000m<sup>2</sup> gelandet. Das Unternehmen verfügt über 3 Extrusionslinien mit einer Kapazität von 2750, 1850 und 1540 Tonnen. Die Strangpresse 2750 des Unternehmens ist eine der größten automatischen Pressen der Branche, die 310 mm breite und 13,4 Meter lange gehärtete Profile herstellen kann.

Mit einer Produktionskapazität von mehr als 20.000 Tonnen pro Jahr ist das Unternehmen in der Herstellung von Standardprofilen, Sigma-Profilen, Möbelprofilen, LED-/Kühlprofilen und Solarenergieprofilen tätig.

### Wettbewerbsvorteile

Das Unternehmen hat eine starke Strategie zur Risikominderung, indem es seine Kundenbasis diversifiziert. Es verkauft an Industrieunternehmen und Baufirmen in der ganzen Türkei (über 20 Länder und über 300 Kunden im Ausland).

### Möglichkeiten

Der Verbrauch von Primäraluminium ist zwischen 2013 und 2017 weltweit um 21,3% gestiegen, was die Dynamik des nachgelagerten Marktes und die höhere Marktdurchdringung des Metalls widerspiegelt. Das Wachstum der weltweiten Aluminiumnachfrage wird bis 2021 voraussichtlich 3,8% betragen.

Im Jahr 2019 betrug die Größe des globalen Aluminiummarktes 123,2 Milliarden USD. Auf die Produktgruppe Stangen, Bleche und Walzen entfielen 26,7% des weltweiten Aluminiummarktes.
