Spanischer Fußballverein „Tercera División RFEF“

Tercera División RFEF, manchmal auch nur Tercera RFEF genannt, ist die fünfte Liga des spanischen Fußballligasystems. Es ist unterhalb der Primera División (auch bekannt als La Liga), der Segunda División und der semiprofessionellen Divisionen Primera División RFEF und Segunda División RFEF. Es wurde 1929 als dritte Ebene gegründet und fiel 1977 bzw. 2021 auf die vierte und fünfte Ebene zurück.

Eine großartige Gelegenheit, einen spanischen Fußballverein in der "Tercera División RFEF" (Dritte spanische Liga) zu erwerben. Derzeit ist der spanische Fußballverband der Königliche Spanische Fußballverband (RFEF), der für seine Nationalmannschaften und seine Ligen verantwortlich ist, wobei die höchste Liga La Liga ist. Am Ende der Saison qualifizieren sich die ersten vier Teams jeder Gruppe für die Aufstiegs-Playoffs, um zu entscheiden, welche Teams in die Segunda División RFEF aufsteigen.

Mindestens die drei Gruppenletzten jeder Gruppe können in die Divisiones Regionales de Fútbol absteigen. Die Anzahl der absteigenden Mannschaften kann jedoch variieren. Die achtzehn Gruppenmeister qualifizieren sich auch für die Copa del Rey der folgenden Saison. Reservemannschaften sind jedoch nicht spielberechtigt. Zusammen mit Teams der Segunda División RFEF treten die verbleibenden Teams der Division in der Copa Federación an.
